Explanation of Responses:

This Form 4 is filed on behalf of Luther King Capital Management Corporation (LKCM), LKCM Private Discipline Master Fund, SPC, on behalf of its wholly-owned subsidiary PDLP Lawson, LLC (PDP), on, LKCM Investment Partnership, L.P. (LIP), LKCM Micro-Cap Partnership, L.P. (Micro), LKCM Core Discipline, L.P. (Core), J. Luther King, Jr. and J. Bryan King (Reporting Persons). LKCM Private Discipline Management, L.P. holds the management shares of PDP, and LKCM Alternative Management, LLC (PDP GP) is its general partner. LKCM Investment Partnership GP, LLC (LIP GP) is the general partner of LIP. LKCM Micro-Cap Management, L.P. is the general partner of Micro. LKCM Core Discipline Management, L.P. (Core GP) is the general partner of Core. LKCM is the investment manager for PDP, LIP, Micro and Core. J. Luther King, Jr. is a controlling shareholder of LKCM and LIP GP, and J. Luther King, Jr. and J. Bryan King are controlling members of Micro GP and Core GP.

2. Includes (i) 1,376,494 shares held by PDP, (ii) 200,938 shares held by LIP, (iii) 19,802 shares held by Micro, (iv) 8,628 shares held by Core, and (v) 2,500 shares held by a separately managed portfolio for which LKCM serves as investment adviser.
